Gretchen Evans, Retired U.S. Army Command Sergeant Major, Dallas/Fort Worth, Texas

As one of the most highly decorated U.S. Army women, Gretchen Evans finally achieved her dream: She oversaw 30,000 troops as a command sergeant major and was on top of the world. But that changed during a rocket attack in Afghanistan when she suffered catastrophic injuries and became deaf. Evans' presentation will take you on a journey from finding her purpose in the military to her decision to reclaim her life with the support of her "rope team." With her team of friends, supporters and service dogs, she rediscovered the will to live. A 2023 Pat Tillman ESPY Award Winner, she dedicated her life to serving others by founding Team Unbroken, a mixed-ability athletic team. Between her stories, Evans will offer wisdom about grit, hope and overcoming barriers. With a heartfelt message and a touch of humor, she inspires others to believe that what's within us is more potent than anything in our way.

FACULTY



Kristin Dillon, M.D., is the chief medical officer for the Federal Office of Rural Health Policy. Dr. Dillon provides advice about clinical care and rural health to support the office's programs and other initiatives across the Department of Health and Human Services. Her areas of expertise include maternal health, mental illness and substance use disorders, health system redesign, clinical quality improvement, and building resilient, trauma-informed teams and organizations. Dr. Dillon is a family physician with 25 years of clinical experience. Her background in rural primary care includes clinic, nursing home, obstetrics, inpatient and emergency department services. After transitioning her focus to policy and administrative work, Dr. Dillon has spent the past eight years in leadership roles with the Oregon Medicaid program, the U.S. Congress and the State of Oregon's COVID-19 response. She graduated with honors from the medical school at the University of California, San Francisco, and Dartmouth College, with a double major in chemistry and Asian studies.



Shawn DuBravac, Ph.D., wrote The New York Times bestseller "Digital Destiny: How the New Age of Data Will Transform the Way We Work, Live and Communicate." This book explores how the mass adoption of digital technologies portends the beginning of a new era in business, health care, finance, transportation and culture. By providing an elevated view of developing trends, Dr. DuBravac empowers leaders and their organizations to improve strategic decision-making capabilities by identifying and understanding the changing landscape. Today, DuBravac is president of Avrio Institute. Its clients include Fortune 100 and Global 1000 companies, scrappy startups, government agencies and nonprofit organizations. Grounded in economics, Dr. DuBravac served for over a dozen years as chief economist for the Consumer Technology Association, a trade association representing more than 2,000 consumer technology companies and owner and producer of the Consumer Electronics Show.



Ret. Command Sgt. Maj. Gretchen Evans is one of U.S. history's most decorated female veterans. She was a successful senior military intelligence analyst and paratrooper, operating in several high-tempo and dangerous missions worldwide, including in Grenada, Kosovo, Bosnia, Somalia, Iraq and Afghanistan. In 2006, while working as a sergeant major in Afghanistan, a mortar blast threw her into a concrete bunker wall. She suffered a traumatic brain injury and lost 95% of her hearing, ending her career in the military. Evans received the Bronze Star for valor and heroism in combat. She shares compelling and riveting stories and experiences, from being the highest enlisted rank in the Army to traversing through life after a severe combat injury. Evans' insightful and poignant perspective offers a view into a window of today's warriors with nuggets of wisdom and impactful takeaways. She shares her story with encouragement, hope and humor. Evans' story is featured in the bestselling book, "What's Within You." In August 2020, Evans and her adventure racing team were featured in the "World's Toughest Race" on Amazon Prime. Her team was the first disabled team to compete in this arduous adventure race.



L. Lavon Gray, Ph.D., is an organizational conflict specialist, award-winning author, business owner, professor and NCAA football referee. From conference rooms filled with bully bosses and passive-aggressive co-workers to college football stadiums filled with screaming coaches and out-of-control fans, Dr. Gray has seen it all when it comes to conflict. More importantly, he learned to thrive in the middle of the chaos. Over the past 30 years, Dr. Gray has accumulated over 7,000 hours of experience, helping leaders resolve conflict, gain traction and lead their organizations to healthier futures. A graduate of the University of Southern Mississippi with a bachelor's degree in political science, Dr. Gray also holds a doctorate with a specialization in administration, an MBA in entrepreneurship and family enterprise from Louisiana State University in Shreveport, and certificates in mediation from Northwestern University, conflict resolution from Cornell University, and leadership and persuasion from Harvard University. Dr. Gray has written five books, including "Never Wrestle With Pigs: A Survival Guide for Dealing with Difficult Personalities." He is co-owner and CEO of the Blue Hen Agency, an organizational health firm in Hattiesburg, Mississippi.



Jody Rogers, Ph.D., is a health care administration graduate program professor at Trinity University in San Antonio. Dr. Rogers has more than 30 years of experience as a health care executive in public and private health care organizations and is a certified master facilitator of The Leadership Challenge. He obtained his master's degree in health care administration from the U.S. Army-Baylor University and his doctorate in health services research, policy and administration from the University of Minnesota.



Shannon Wu, Ph.D., is the American Hospital Association's senior associate director of payment policy, focusing on the association's work on Medicare inpatient hospital and rural hospital issues. Dr. Wu came to AHA from Cornerstone Research, where she was an associate working on various economic analyses for health care litigation matters, including hospital mergers and provider reimbursements. Previously, she worked for the Office of the Assistant Secretary for Planning and Evaluation at the U.S. Department of Health and Human Services and the Senate Committee on Health, Education, Labor and Pensions. Dr. Wu received her doctorate in health services research and policy from the Johns Hopkins Bloomberg School of Public Health and her bachelor's degree from Princeton University.
