Study finds many rural Iowa hospitals at risk of closing

A study by the [Center for Healthcare Quality and Payment Reform](#) has found that 24 of Iowa's rural hospitals were at immediate risk of closure before the COVID-19 pandemic because of continuing financial losses and lack of financial reserves to sustain operations. These hospitals had low or nonexistent financial reserves and persistent financial losses.

These estimates likely underestimate the severity of the problem that exists today. Margins at many Iowa hospitals may have been worse in 2020 because of the combination of the higher costs that

hospitals incurred during the pandemic and the reduction in revenues because patients avoided seeking nonemergency services.

An additional 16 rural Iowa hospitals are at high risk of closure in the future. These hospitals have a high dependence on nonpatient service revenues and low financial reserves. In total, 40 rural Iowa hospitals – 44% of all rural hospitals in Iowa – are either at immediate risk or high risk of closure.

The study was released as part of a white paper titled "[Saving Rural Hospitals and Strengthening Rural Healthcare](#)." The publication identifies the reasons why small rural hospitals face such severe financial problems and examines the potential effectiveness of several commonly proposed policies for rural hospitals.
