## Medicare 2% sequester cuts suspended through March

The 2021 Consolidated Appropriations Act, signed into law Dec. 27, extends the suspension of the payment adjustment percentage of 2% applied to Medicare fee-for-service claims to March 31. The CARES Act initially suspended the payment adjustment percentage from May 1 through Dec. 31, 2020.
