IDPH rescinds COVID-19 vaccine shortage orders

Effective immediately, all vaccine shortage orders issued by the Iowa Department of Public Health from December 2020-March 2021 are rescinded. Anyone 16 and older now can receive a vaccination from an enrolled COVID-19 vaccine provider.

Enrolled vaccine providers may refer to the [Iowa Department of Public Health COVID-19 Vaccine Administration Policy](#), dated April 5, 2021, for guidance about prioritization and immunity protections.


