### **UnitedHealthcare temporarily suspends prior authorization requirements**

UnitedHealthcare is temporarily suspending prior authorization requirements for all in-network hospitals and skilled nursing facilities in Iowa. The suspension is because of increasing COVID-19-related emergency department visits, admissions and transfers.

The adjustments will affect UnitedHealthcare Medicare Advantage and individual and group market health plan members. The suspension is effective Jan. 14-Feb. 11.

Prior authorization suspensions include:

- Admissions to in-network skilled nursing facilities.
- COVID-19-related oxygen requests.
- Discharge and post-acute care assistance.

- Transfers to a new in-network facility.

### **Website launched to order free COVID-19 test kits**

The Biden Administration launched a [new website](#) where Americans can order up to four free at-home COVID-19 test kits. The United States Postal Service will start shipping requested kits in late January.

The administration [said](#) it also will launch a phone line where those without online access can order the tests and will work with national and local organizations to help high-risk communities request the tests. The administration's goal is to make 1 billion at-home tests available to the public.

### **IDPH therapeutics update includes weekly COVID-19 treatment allocations**

The Iowa Department of Public Health therapeutics update included the state's weekly allocations of monoclonal antibodies, preexposure prophylaxis treatment and antivirals. IDPH is working to prioritize allocations of therapeutic products based on the regional trends of variants.

For the week of Monday, Jan. 17-Sunday, Jan. 22, IDPH received:

- 290 courses of Bam/ete.
- 360 courses of Regen-Cov.

- 318 courses of Sotrovimab.
