Remember to renew hospital license

Hospitals operating in Iowa must annually renew their license through the [Health Facilities Division](#) of the Department of Inspections and Appeals. The department emailed the application and letter to hospital administrators Monday, Nov. 14. Facilities include:

- Acute.

- Critical access.
 - Long-term acute care.
 - Psychiatric.
 - Rehabilitation.

Apply for rural opioid response funding

New grant funds to reduce the incidence and impact of neonatal abstinence syndrome in rural areas have been made available through the Health Resources and Services Administration. It's Federal Office of Rural Health Policy is making a [\\$20 million investment](#) with 40 grants of up to \$500,000 each.

Recipients will work with local, state and regional stakeholders to provide coordinated, trauma-informed and family-centered behavioral and maternal health care services for three years. The services include medicine-assisted treatment for rural pregnant and postpartum patients and their families.

Applicants may be based in urban or rural areas, but all activities supported by the program must occur exclusively in [designated rural areas](#). A [webinar for interested organizations](#) is scheduled from 1-2 p.m. Wednesday, Jan. 4, 2023. [Applications are due Wednesday, March 8, 2023.](#)
