The second week of the legislative session was a shortened because of the Martin Luther King Jr. holiday. Legislators did little floor work this week and focused on committee and subcommittee meetings. As the session progresses, bills will move fast. ## Legislation on the move

### Tort reform

Gov. Kim Reynolds listed medical malpractice reform as a priority in her Condition of the State address. IHA is anticipating a bill on this topic and hoping to see language soon. When introduced, IHA expects the bill to move quickly through the legislative process. IHA encourages you to contact your legislators and voice your support for tort reform.

### Introduced bills

Dozens of bills were introduced, and subcommittees met during the second week of the legislative session. Below is an overview of bills introduced by legislators that affect hospitals. [Click here](#) to view a complete list of legislation IHA is following.

### Workforce

- **Last Dollar Scholarship Fund** – House Study Bill 541 and companion bill Senate Study Bill 3046 allow part-time students in certain fields, including health care, to qualify for the Last Dollar Scholarship Fund administered by the Iowa College Student Aid Commission. IHA supports this legislation.
- **Psychiatric residencies** - House Study Bill 532 requires the University of Iowa Hospitals and Clinics to administer a psychiatric residency program at the Cherokee and Independence mental health institutions and at the Oakdale Classification Center. The bill establishes a fund for the program with 12 positions and gives preference to Iowans who attended college or medical school in Iowa. IHA supports this legislation.
- **Mental health professional loan-repayment program** – House Study Bill 537 creates a new prescribing mental health practitioner loan-repayment program to provide loan repayment for prescribing mental health practitioners who agree to practice in designated areas for at least five years. An eligible student must complete an Iowa-based residency and priority is given to Iowa residents who apply for the program. IHA supports this bill.

### Medicaid

- **Medicaid eligibility and verification** – Work on the Medicaid eligibility and verification package continued this week. Several bills for Medicaid eligibility and verification were introduced. A subcommittee reviewed House Study Bill 502 Tuesday. The bill requires the Department of Human Services to redesign or establish a new system for verifying eligibility for public assistance internally or through a third-party contract. The subcommittee tabled work on this bill and

did not pass it out to a full committee. The subcommittee will revisit the bill in the future. A subcommittee reviewed and advanced House Study Bill 504 last Thursday. HSB 504 requires public assistance applicants to complete a computerized identification-authentication process. Lastly, a bill about public assistance program case reviews, House Study Bill 515, was discussed during a subcommittee and voted down.

- **Iowa Health and Wellness Plan** – A bill about reenrollment following termination from the Iowa Health and Wellness plan, House Study Bill 506, was reviewed in a subcommittee Thursday. Like HSB 502, the bill was tabled and was not passed out to a full committee. The subcommittee will revisit the bill in the future.

## Behavioral health

- **Tiered psychiatric reimbursements** – House Study Bill 530 requires the Department of Human Services to implement a tiered reimbursement methodology for Medicaid psychiatric inpatient care based on the patient's acuity and other factors identified by the Inpatient Bed Tracking System Study Committee, of which IHA and Iowa hospitals were members. Through meeting with legislators, IHA learned the Senate may introduce their own proposal on this topic. IHA supports this legislation.

## COVID-19 bills

Several bills about COVID-19 were introduced. None of the bills were reviewed in a subcommittee and it is unclear if any of them have a path to passage.

- **COVID immunity proof** – House File 2034 and Senate File 2030 would require any entity that requires proof of a COVID-19 vaccination to accept proof of COVID-19 immunity, through a positive COVID-19 test or a test confirming the presence of COVID-19 antibodies, in the last three months.
- **COVID-19 testing** – House File 2036 would require any business requiring COVID-19 testing as an alternative to staff vaccination to pay all costs related to the test, including paying the employee for time away from work. The bill also would prohibit requiring employees to get tested outside normal work hours.
- **COVID-19 and hospitals** – Senate Study Bill 3035 would exempt a health care facility from the certificate-of-need process if the facility will be developed in a county where the hospital requires employees to receive a COVID-19 vaccine.
- **COVID-19 vaccination incentives** – Senate Study Bill 3037 would disallow a health insurer or public employee health care plan from providing incentives to a provider for meeting COVID-19 vaccination goals or imposing penalties on providers for not meeting vaccination goals.

### Webinar series to focus on antibiotic stewardship

The Iowa Healthcare Collaborative and the Iowa Department of Public Health will host the Antibiotics Steward Series, which is aimed at improving antibiotic prescribing by clinicians and use by patients. The first webinar in the series, Using the Core Elements to Promote Innovation, will feature Brian Isetts, RPh, Ph.D., a professor at the University of Minnesota College of Pharmacy.

Dr. Isetts will discuss:

- Antibiotic stewardship care elements.
- Best practices of stewardship through hospital sharing.
- Accomplishments of successful implementation.

## **Pfizer Tris COVID-19 vaccine available in Iowa**

Pfizer Tris, the Pfizer COVID-19 vaccine for people 12 years and older, is available to health care providers. This formulation has a distinctive grey cap and:

- Does not require diluent.
- Is available in smaller 300-dose configurations.
- May be stored at 2-8 degrees C for up to 10 weeks.

The Pfizer COVID-19 vaccine with the purple cap was retired Dec. 31, 2021. Health care providers should use existing Pfizer formulations (1170- and 450-dose packs) to the greatest extent possible.
