### Miller-Meeks, Wild urge swift action to prevent looming Medicare cuts

U.S. Reps. [Mariannette Miller-Meek, M.D.](#), and [Susan Wild](#) are the primary authors of a letter urging quick action to prevent the more than 8% cut in Medicare reimbursement. This cut comes on the heels of the 2% sequestration cut that resumed in July 2022. The letter was sent to President Joe Biden, U.S. Senate Majority Leader Chuck Schumer, U.S. Senate Minority Leader Mitch McConnell, U.S. House of Representatives Speaker Nancy Pelosi and U.S. House of Representatives Minority

Leader Kevin McCarthy.

The letter explains that the reimbursement cuts would “directly harm our nation’s medical groups, physicians, hospitals and other health care providers who care for our communities.” The reimbursement reductions are being driven by the 4% Statutory Pay-As-You-Go requirement and a 4.47% cut to the Medicare conversion factor, which affect many health care providers.

Compounded by workforce shortages, increased costs, supply chain issues and the ramifications of the COVID-19 pandemic, these cuts may not only affect the ability of providers to care for patients but also force service shutdowns, staff furloughs, hiring freezes and population health initiative delays.

IHA has advocated on this issue with Iowa’s Congressional delegation and thanks Rep. Miller-Meeks for her action.

### **CMS releases 2023 Medicare physician fee schedule**

The [2023 physician fee schedule](#) published by the Centers for Medicare and Medicaid Services includes public updates for Medicare telehealth services. The policy changes make several services that are temporarily available through the COVID-19 public health emergency available at least through calendar year 2023. The move allows CMS to collect data that may support telehealth services’ inclusion as permanent additions to the Medicare telehealth services list.
