## **Week No. 7 summary**

After the first legislative funnel last week, both chambers saw more floor debate this week. This included a bill that would allow, but not require, compensation for county hospital trustees. Current law allows for reimbursement of expenses, but does not allow for compensation.

[House File 2428](#) passed the House floor nearly unanimously and is making its way to the Senate. This bill will give county hospitals the option to reimburse volunteers if they want. Next week, [House File 2521](#), health care employment agencies, is scheduled to hit the House floor. This legislation requires health care employment agencies to register with the Department of Inspections and Appeals and provide more price transparency.

Thank you for your quick responses to the IHA action alerts about tort reform and the certificate-of-need process. There have been more than 100 messages about each topic sent to legislators. ## Legislation on the move

### Last Dollar Scholarship - [HF 2165](#)

**What the bill does:** Expands the eligibility of the Future Ready Iowa Skilled Workforce Last-Dollar Scholarship to part-time students.

**Sponsor:** College Study Aid Commission.

**Status:** On the House debate calendar.

**IHA position:** IHA is supportive of programs that support recruitment and retention efforts for the health care workforce.

### Mental health loan repayments - [HF 2137](#)

**What the bill does:** Creates a prescribing mental health professional loan-repayment program in the College Student Aid Commission.

**Sponsor:** [Rep. Ann Meyer](#) (R-Fort Dodge).

**Status:** Passed a House Appropriations Subcommittee.

**IHA position:** IHA supports efforts to expand the health care workforce.

### Psychiatric residencies - [HF 2529](#)

**What the bill does:** Creates a state-funded psychiatric residency program at the state mental health institutes and the Iowa Medical and Classification Center at Oakdale, and makes appropriations.

**Sponsor:** [Rep. Ann Meyer](#) (R-Fort Dodge).

**Status:** Passed the House Appropriations Committee.

**IHA position:** IHA supports legislative efforts that expand behavioral health resources in Iowa.

#### **Provisional psychologists - [HF 2246](#)**

**What the bill does:** Allows the Board of Psychology to give doctoral psychology students a two-year provisional license during the student's internship and authorizes them to practice under the supervision of a licensed psychologist.

**Sponsor:** [Rep. Joel Fry](#) (R-Osceola) and [Rep. Ann Meyer](#) (R-Fort Dodge).

**Status:** Passed the House 97-1 and goes to the Senate.

**IHA position:** IHA is monitoring this bill and assessing the impact for hospitals.

#### **Health worker employment agencies - [HF 2371](#)**

**What the bill does:** Requires health care employment agencies to register with the Department of Inspections and Appeals and establishes fees defining the agencies. The bill also requires the agency to make employees comply with the requirements and qualifications for health care workers.

**Sponsor:** [Rep. Ann Meyer](#) (R-Fort Dodge).

**Status:** Passed the House Ways and Means Committee.

**IHA position:** IHA is monitoring this bill and assessing the impact for hospitals.

#### **Prior authorizations - [HF 2399](#)**

**What the bill does:** Prohibits a utilization review committee from limiting or revoking a prior authorization after the health care service was provided and requires the provider be reimbursed at the contracted rate.

**Sponsor:** [Rep. Shannon Lundgren](#) (R-Peosta).

**Status:** Passed the House 97-0 and goes to the Senate.

**IHA position:** IHA supports this bill because it streamlines the prior-authorization process.

#### **Tiered psychiatric reimbursements - [HF 2125](#)**

**What the bill does:** Reimburses psychiatric intensive inpatient care under the Medicaid program.

**Sponsor:** [Rep. Ann Meyer](#) (R-Fort Dodge).

**Status:** Passed a House Appropriations Subcommittee.

**IHA position:** IHA is supportive of expanding behavioral health services for patients with highly complex needs.

#### **Pharmacy matters - [HF 2169](#)**

**What the bill does:** Allows registered nurses to give immunizations and vaccines under the order of a pharmacist using state protocols without a registration from the Board of Pharmacy.

**Sponsor:** Board of Pharmacy.

**Status:** Passed the House 94-1 and goes to the Senate.

**IHA position:** IHA is monitoring this bill and assessing the impact for hospitals.

#### **Physician assistant duties - [HF 803](#)**

**What the bill does:** Adds additional duties that may be performed by physician assistants.

**Sponsor:** [Rep. Ann Meyer](#) (R-Fort Dodge).

**Status:** Passed the Senate State Government Committee.

**IHA position:** IHA is monitoring this bill and assessing the impact for hospitals.

#### **Health care facility violations - [HF 2172](#)**

**What the bill does:** Updates rule citations for self-reported violations by health care facilities.

**Sponsor:** Department of Inspections and Appeals.

**Status:** Passed the House 95-0 and goes to the Senate.

**IHA position:** IHA is monitoring this bill and assessing the impact for hospitals.

#### **Midwife licensing - [HF 2291](#)**

**What the bill does:** Requires practicing midwives to hold a license by July 2023, establishes requirements and a board, and limits the liability of health care providers who accept transfers of patients from midwives.

**Sponsor:** [Rep. Bobby Kaufmann](#) (R-Wilton).

**Status:** Passed a House Ways and Means Subcommittee.

**IHA position:** IHA does not support this bill because of safety and quality concerns.

## Health systems and hospitals urged to increase cybersecurity

Hospitals and health systems are urged to remain vigilant against health care cyber attacks amid the Russian invasion of Ukraine.

The [American Hospital Association identified three concerns](#) for the health care sector about increased Russian-borne cyber threats:

- Hospitals and health systems may be targeted directly by Russian-sponsored cyber actors.
- Hospitals and health systems may become incidental victims of, or receive collateral damage from, Russian-deployed malware and destructive ransomware that inadvertently penetrates U.S. health care entities.
- Cyberattacks could disrupt hospitals' mission-critical service providers.

The Cybersecurity and Infrastructure Security Agency also issued a Shields Up advisory recommending all organizations employ enhanced security measures. CISA recommends organizations:

- Prepare to respond if an intrusion happens.
- Maximize resilience to a destructive cyber incident.
- Reduce the likelihood of a damaging cyber intrusion.
- Take steps to quickly detect a potential intrusion.

CISA has cataloged free services from government partners, the open-source community and Joint Cyber Defense Collaborative companies to help with cybersecurity needs.

## **IHA releases latest hospital data trends**

IHA has collected data trends from 99 Iowa hospitals for [January-December 2021](#) as compared with the same time frame in 2020:

- Acute discharges increased 1% as acute patient days increased 5.8%.
- Ambulatory surgery visits (hospital-based) increased 15.8%.
- Average length of stay increased 4.2%.
- Births increased 2.4%.
- Charity care increased 1.4%.
- Emergency department visits increased 11.8%.
- Facility employment (excluding physicians) increased 8.4%.
- Inpatient admissions from the emergency department increased 3.8%.
- Inpatient surgeries decreased 0.7%.
- Medicaid acute discharges increased 3.6% and Medicaid acute patient days increased 3.4%.
- Net patient revenue (collected charges) increased 11%.
- Outpatient utilization increased 20.3%.
- Total expenses increased 9.3%.
- Uncompensated care (bad debts) increased 6.2%.
