## **Legislature wraps up second funnel week**

The second legislative funnel week of 2022 wrapped up last week, and IHA's advocacy team and hospital advocates worked hard to maintain the certificate-of-need process. The original bill that would have eliminated the certificate-of-need process died, but an amendment was attached to another bill about transparency for ambulatory surgical centers, House File 2248. The amendment carves out birthing centers and behavioral health services from the certificate-of-need process. It also increases the thresholds for capital projects from \$1.5 million to \$5 million and for purchasing new equipment from \$1.5 million to \$3 million.

In other action, workforce bills backed by Gov. Kim Reynolds were introduced in the House and Senate including loan repayment and reward programs to recruit providers to rural communities. The bills passed subcommittees and committees in both houses and are now in ways and means committees.

Other bills the advocacy team tracked include:

- Allowing registered nurses to administer vaccines under the direction of licensed pharmacists.
- Medicaid and fiscal issues.
- Medical malpractice (tort) reform.
- Prior authorization.
- Rural emergency hospital licensure.

- Volunteer emergency medical services tax abatements.
- Workforce.

## **HRSA begins implementation of 340B eligibility exceptions for some hospitals**

The Health Resources and Services Administration sent notices about implementing Sec. 121 of the Consolidated Appropriations Act of 2022.

The new law protects certain qualifying 340B hospitals that lost their 340B eligibility because of a drop in their disproportionate-share-hospitals adjustment percentage below the required threshold to gain limited access to the program. Access to the 340B drug discounts will be available from the date of enactment through the end of 2022.

**The notice was sent only to hospitals that were removed from the 340B program because they didn't meet the statutorily required disproportionate-share-hospitals adjustment percentage.** Impacted hospitals would have received notification Friday, March 18.

## **Dr. Lorna Breen Act is officially law**

The Dr. Lorna Breen Health Care Provider Protection Act ([H.R. 1667](#)) was signed into law by President Joe Biden Friday. The American Hospital Association-supported bill aims to improve the mental health and well-being of health care workers.

The legislation authorizes grants for programs that offer behavioral health services for front-line health care workers. The bill also requires the U.S. Department of Health and Human Services to recommend strategies to facilitate health care provider well-being and to launch a campaign encouraging health care workers to seek assistance when needed.

The bill is named for Lorna Breen, M.D., who was chair of the emergency department at New York-Presbyterian Allen Hospital in New York City. Dr. Breen died by suicide April 26, 2020, toward the beginning of the pandemic.
