## **Biden, AHA issue cybersecurity advisories**

President Joe Biden [urged](#) an immediate hardening of private-sector cyber defenses based on evolving intelligence that the Russian government is exploring options for potential cyberattacks.

The White House [issued a fact sheet](#) with steps organizations can take to protect against potential cyberattacks. Foremost among the steps are the implementation and mandated use of multifactor authentication.

The American Hospital Association further outlines steps specific to hospitals and health systems. Actions include:

- Checking the redundancy, resiliency and security of organization networks and data backups.
- Geo-fencing all inbound and outbound traffic originating from and related to Russia, Ukraine and its surrounding regions.
- Identifying all internal and third-party mission-critical clinical and operational services and technology.

## **FDA authorizes new at-home COVID-19 test**

Last week, the Food and Drug Administration [authorized for emergency use](#) a new

over-the-counter COVID-19 test. The Indicaid COVID-19 Rapid Antigen At-Home Test provides results in about 20 minutes. The test is similar to other at-home tests that collect samples with nasal swabs.


### **Shelf life extended for COVID-19 antibody treatment Sotrovimab**

Drug manufacturer GSK reported Sotrovimab doses with an expiration date of February 2022 received a shelf-life extension until August 2022. All other doses of the drug have an 18-month shelf life.

Health care providers should check with the manufacturer before disposing of the product. After verifying the expiration date, expired doses should be disposed of according to the facility's standard operating procedures.

GSK created a call center to help health care providers determine shelf life and expiration dates. Call GSK at 866-GSK-COVID.




