Allen Anderson named president and CEO of St. Anthony Regional Hospital



Anderson will succeed Ed Smith, who has been president and CEO since 2012 and will help with the transition.

COVID-19 vaccine administration reporting schedule updated

The Iowa Department of Public Health announced the reporting of vaccine data to the COVID-19 Vaccine Administration Dashboard and the Domo app will transition to monthly reporting beginning Tuesday, May 3. Additional data out of the monthly timeframe will not be available.

IHA submits comments for OSHA COVID-19 health care ETS

[IHA submitted comments Friday](#) for the recently reopened Occupational Safety and Health Administration's comment period for certain topics in its interim final rule. The interim final rule established an emergency temporary standard for occupational exposure to COVID-19.

OSHA published the interim final rule creating the emergency temporary standard on June 21, 2021, at which time [IHA submitted initial comments to delay enforcement](#) because some of the standard's provisions caused significant concern to hospitals. IHA's stance has not changed.

[An informal public hearing](#) will begin Wednesday, April 27, and will continue on April 28-29 and Monday, May 2.
