Nurses Week begins Friday

Friday kicks off Nurses Week, a recognition of nurses' contributions and sacrifices they make to keep us healthy. Nurses Weeks is celebrated between May 6 and May 12, the birthday of Florence Nightingale and International Nurses Day.

EMTALA series content updated

Recent citations in Iowa have prompted Nancy Ruzicka, speaker for the [Emergency](#)

[Medical Treatment and Labor Act Series](#), to update the content for the series.

There have been an increasing number of investigations and escalating civil monetary penalties for noncompliance. The series' revised content will review the basic requirements of EMTALA and examine the most problem-prone areas of medical screening examinations and appropriate transfers. Ruzicka also will discuss recent deficiencies and civil monetary penalties in the U.S. and EMTALA violations in behavioral health settings.

The virtual series still is scheduled to begin Wednesday, May 11.

IHA wins gold for 'I've Had It' ad campaign

More than 4,300 entries were submitted for the [39th Annual Healthcare Advertising Awards](#) and IHA won gold in the COVID-19 Response Materials for the ["I've Had It" COVID-19 vaccination campaign](#).

The campaign was aimed at encouraging Iowans to get their COVID-19 vaccinations and ran across print, television, radio and digital platforms. The campaign was funded by a grant from the Iowa Department of Public Health.

The [University of Iowa Health Care](#) also won a silver award in the COVID-19 Marketing Campaign category for its vaccine print series.

A national panel of judges reviewed all entries based on creativity, quality, message effectiveness, consumer appeal, graphic design and overall impact, with 512 Gold awards presented.

IHA PAC Committee Sets 2022 Goal

The IHA PAC Committee met April 29 and approved a statewide campaign goal of \$125,000. It's the same goal as last year. Expectations for all 118 hospitals and the health systems engaging in the PAC were discussed. IHA President and CEO Chris Mitchell told committee members that when the PAC isn't strong, the hospital community is disadvantaged.

Committee actions also included:

- Amending PAC bylaws to have the IHA board chair-elect serve as PAC chair. Currently, the immediate past-chair of the board leads the committee.
- Approving new hospital and health system goals.
- Discussed and confirmed campaign messaging.

FDA approves first COVID-19 treatment for younger children

The U.S. Food and Drug Administration [expanded the approval of the COVID-19 treatment Veklury \(remdesivir\)](#) to include pediatric patients 28 days and older weighing at least 3 kilograms, or about 7 pounds who are:

- Hospitalized.
 - Not hospitalized and have mild-to-moderate COVID-19 and are at high risk for progression to severe COVID-19 including hospitalization or death.
