### Infant, toddler COVID-19 vaccines approved for emergency use

The Food and Drug Administration gave emergency-use authorization Friday for both the [Pfizer-BioNTech and Moderna COVID-19 vaccines for children 6 months and older](#). The Centers for Disease Control and Prevention signed off on the plan Saturday.

The CDC's recommendations differ for the Pfizer-BioNTech vaccine and the Moderna vaccine. The CDC recommends:

- Children 6 months-4 years old should receive a three-dose primary series of the Pfizer-BioNTech vaccine. The first and second doses should be separated by three to eight weeks and the second and third doses should be separated by at least eight weeks.
- Children 6 months-5 years old should receive a two-dose primary series of the Moderna vaccine separated by three to eight weeks and one booster dose at least five months after completion of the primary series.

Health care providers should continue to vaccinate 6-17 year olds with the Pfizer-BioNTech COVID-19 vaccine.
