### IHA advocacy team weekly preview

Campaign season is in full swing. An unprecedented number of seats are open for the 2022 midterms, and the IHA advocacy team continues to schedule candidate interviews and attend candidate events.

The advocacy team is:

- Participating in meetings with the American Hospital Association and other state hospital associations. Issues on the agendas include workforce shortages, insurer accountability, sustaining hospital finances and the wind down of the national public health emergency. Washington updates from House and Senate leadership are also on the docket.
- Meeting with Iowa College Aid to discuss administrative rules for the Mental Health Professional Loan Repayment Program. They also will discuss changes to [SF2383](#), Gov. Kim Reynolds' workforce bill and its impact to health care workforce recruitment programs.
- Meeting with the [Master Builders of Iowa](#) this week to discuss [SF183](#). The bill allows Iowa public bodies to use the Construction Management At-Risk delivery method and prohibits the use of single-contract design-build delivery methods. The bill goes into effect Friday, July 1.

It formalizes a non-adversarial process with open communication about what happened, why it happened and what can be done to prevent it.
