

The Centers for Medicare and Medicaid Services updated its condition of participation for infection prevention and antibiotic stewardship on March 30, 2020. Nancy Ruzicka, a consultant on state and federal rules, will lead a regulatory webinar regarding the updates.

Ruzicka will discuss commonly cited deficiencies, the CMS COVID-19 and infection control worksheets and interpretive guidelines. Hospital C-suite officers, compliance officers, legal counsel, pharmacists, physicians and quality improvement staff are encouraged to attend.

## Alicia Reed named CHI Health Mercy Corning president

After serving as interim president of [CHI Health Mercy Corning](#), Alicia Reed was named permanent president of the facility on July 10. Reed had been the interim president since February after previous president Kurt Sargent accepted a position as chief financial officer for Hills and Dales General Hospital in Cass City, Michigan.

Reed started her health care career at Mercy Corning as the home medical equipment service line manager and as a respiratory therapist. She eventually took on leadership roles as the supervisor for quality, safety and clinical support services and compliance safety specialist. Before becoming interim president, Reed was the administration network coordinator for 34 critical access hospitals associated with CHI Health.

## IDPH updates remaining COVID-19 therapeutics allocations threshold

The Iowa Department of Public Health encourages organizations who do not receive allocations of therapeutic products to notify and work with prescribers and local public health agencies about the availability of therapeutic products in their communities. IDPH said the [remaining allocations threshold for this week](#) are:

- Bebtelovimab – 205 courses.
- Evusheld – 1,608 doses (monthly allocation).
- Molnupiravir – 384 courses.
- Paxlovid – 1,060 courses.
- Renal paxlovid – 95 courses.
