# IHA submits REH, CAH conditions of participation comments to CMS

Yesterday, IHA submitted comments to the Centers for Medicare and Medicaid Services about the <u>conditions of participation for rural emergency hospitals and</u> updates to the conditions of participation for critical access hospitals.

IHA expressed support for CMS efforts to align the REH conditions of participation with that of CAHs and clarifying several issues within the rules. IHA expressed concerns with quality requirements and laboratory services as well as expressing the need for flexibility in some circumstances to the 24-hour average annual length of stay. IHA encouraged CMS to account for challenges in rural communities including transportation and ambulance availability.

With the CAH conditions of participation, IHA supports the changes, but urged CMS to take caution with the updates and not add excessive burdens to the hospitals.

# Bill would extend Medicare-dependent and low-volume adjustment programs

To extend the Medicare-dependent hospital program and low-volume hospital adjustment, the Assistance for Rural Community Hospitals (ARCH) Act has been introduced by Reps. Carol Miller (R-W.VA) and Terri Sewell (D-Ala.)

The Medicare-dependent hospital program, established in 1987, allows eligible hospitals to receive the sum of their prospective payment system payment rate plus three-quarters of the amount of their cost per discharge that exceeds the proposed payment system rate. As proposed, the ARCH Act would extend the program an additional five years, helping provide financial stability to rural hospitals.

The low-volume adjustment factor accounts for the relation between cost and volume, leveling the playing field for low-volume providers and improving access for care in rural areas. The ARCH Act also proposes a five-year extension for the low-volume adjustment factor.

Sen. Chuck Grassley has introduced a similar bill in the Senate. IHA is pleased the U.S. House and Senate are committed to the financial sustainability of rural hospitals to ensure access to high-quality, affordable care.
