## Remember to apply for 340B program recertification

The deadline to apply for 340B drug pricing program recertification is Monday, Sept. 19. 340B-covered entities must annually recertify their eligibility to remain in the 340B program and continue purchasing covered outpatient drugs at discounted 340B prices.

Hospitals must complete recertification through the OPA Information System (OPAIS). Authorizing officials and primary contacts must create their own OPAIS accounts before recertifying. Covered entities that fail to create OPAIS accounts and conduct recertification will be removed from the 340B program.

The Health Resources and Services Administration provided a <u>slide presentation</u> <u>with more information about the recertification process</u> and <u>educational resources</u> <u>are available online</u>.

## IHA advocacy team weekly preview

## Apply for 2023 nonprofit security grant program

The Iowa Department of Homeland Security and Emergency Management opened the application period for its <u>nonprofit security grant program</u>. The program provides funding support for physical security enhancements and addressing vulnerabilities that could be exploited in an assailant or armed intruder scenario.

Eligible applicants include nonprofit organizations that are:

- Determined to be at high risk of a terrorist attack by the secretary of Homeland Security.
- Described under section 501(c)(3) of the Internal Revenue Code 1986 (IRC) and exempt from tax under section 501(a) of the code.

Interested organizations must submit in its application a verification of vulnerability assessment completed for each occupied building for which funds are being sought. Assessments cannot be more than three years old and must be completed by one of the following:

- Iowa Department of Homeland Security and Emergency Management or contracted third-party.
- · Law enforcement.
- Vulnerability assessment service provider.

Interested organizations must submit a notice of interest by Friday, Nov. 4, and submit completed applications by Thursday, Jan. 12, 2023.
