### IHA advocacy team weekly round up

The advocacy team met yesterday with State Sen. Mark Costello (R-Imogene) to discuss IHA's 2023 legislative priorities. Sen. Costello sits on the Senate Human Resources Committee as vice chair, Appropriations Committee and chairs the Senate Health and Human Services Appropriations Subcommittee.

The advocacy team this week also:

- Attended and monitored discussion held by the Administrative Rules Review Committee meeting regarding workforce loan repayment programs.
- Attended the Children's Behavioral Health System State Board meeting.
- Reviewed and discussed the Mental Health and Disability Services Commission's 2023 legislative priorities.

#### IME creates plan to resume normal business process after PHE

The Centers for Medicare and Medicaid Services recently <u>released guidance</u> <u>outlining requirements and expectations for resuming normal eligibility business</u> <u>processes</u> when the federal COVID-19 public health emergency ends. The lowa Medicaid Enterprise is using the guidance to create a phased approach to resuming normal eligibility processes for lowa.

<u>Phases 1-3 of Iowa Medicaid's plan</u> have been implemented, and the processes in each phase continue to be executed during the public health emergency. Processes continuing to be implemented include:

- Issuing pre-populated annual medical assistance renewal and review forms.
- Transitioning members to a coverage group for which they are now eligible.

## Apply for rural health network grant

The Human Resource and Services Administration Federal Office of Rural Health Policy is offering 44 awards of up to \$300,000 each for the 2023 Rural Health Network Development Program.

The four-year program will support integrated health care networks in:

- · Achieving efficiencies.
- Expanding access, coordination and improvements to the quality of basic health care services and outcomes.
- · Strengthening rural health care.
