
IOWA SOCIETY OF HEALTHCARE ATTORNEYS SPRING CONFERENCE

Former lowa Supreme Court Justice Brent Appel will detail ethics from the judiciary's viewpoint, discuss the role of state and federal courts on legal and judicial ethics, analyze trends in ethics for lawyers and judges, and review hot-button issues surrounding legal and judicial ethics.

This panel discussion will delve into the evolving landscape facing the health care in-house general counsel. From navigating regulatory complexities to managing cybersecurity risks, the panel will discuss what worries persist in the minds of general counsels at academic medical centers and hospital systems. Moreover, the panel will explore the expanding role of the general counsel beyond legal matters, engaging in strategic decision-making and advising on non-legal questions critical to business operations. Despite these responsibilities, concerns linger about compliance, litigation and alignment with organizations' strategic objectives. In-house general counsels continue to emerge as key strategists, guiding organizations through legal, ethical and operational minefields toward growth and longevity.

SPEAKERS

Brent Appel is an attorney and former judge who served as associate justice of the lowa Supreme Court from 2006 to 2022. He was previously the first assistant attorney general of lowa from 1979 to 1983 and deputy attorney general from 1983 to 1987. A native of Dubuque, Justice Appel graduated from Stanford University with concurrent bachelor's and master's degrees in history. He earned his law degree at the University of California, Berkeley.

Wesley Butler is a Barnett Benvenuti and Butler shareholder in Lexington, Kentucky. His law practice focuses on advising health care providers on regulatory, accreditation and legislative matters that implicate safety, quality and reimbursement. Earlier in his career, Butler was a litigation attorney, handling various civil defense matters in federal and state courts. In 2004, Bulter was appointed by the Governor of Kentucky to serve as chief litigation counsel and later general counsel for Kentucky's Health Cabinet. He was lead counsel for the state's Office of the Inspector General and Medicaid agencies and the cabinet's chief legal liaison with CMS and the Office of the Inspector General. After his time in the cabinet, Bulter's practice shifted toward regulatory matters. He continues to be involved in litigation for health care regulation, patient safety and health policy issues. Butler earned his undergraduate and law degrees from the University of Kentucky.

Heather Campbell is managing counsel for Trinity Health and regional general counsel for MercyOne, where she is responsible for all legal matters for MercyOne and is counsel to the MercyOne board of directors. Before joining MercyOne, Campbell was a partner at Belin McCormick in Des Moines. She received her law degree from Drake University and her bachelor's degree in nursing from Grand View University. She is a licensed registered nurse in lowa.

Manuel Cornell is an associate at Dorsey and Whitney. Cornell's practice includes employment, personal injury and complex commercial disputes. He is a member of the executive council of the lowa Bar Association's Young Lawyers Division and co-chairs the division's diversity committee. Cornell is also a member of the board of directors for Orchard Place in Des Moines and a member of the board of advisers for the Association of Latinx Professionals.

Curt Chase is a partner at Husch Blackwell in Kansas City, Missouri. Chase has developed a national health care practice providing transactional, regulatory and compliance guidance for hospitals, physicians and other health care providers. He routinely serves as outside counsel to hospitals and health systems for complex hospital/physician integration arrangements. Chase is also experienced in handling compliance and reimbursement matters, including government investigations and internal compliance reviews. He earned his bachelor's degree from Yale University, his master's degree in health administration from the University of lowa and his law degree from the University of lowa.

Todd Chelf is executive vice president and general counsel at Great River Health in West Burlington, overseeing corporate governance, regulatory compliance, contract administration, provider compensation and risk management. Before joining Great River Health, Chelf was first assistant county attorney for Des Moines County, where he prosecuted sexually related crimes and other significant felonies. Before his public service, he was a partner in the law firm of Cray, Goddard, Miller, Taylor and Chelf. Chelf earned his bachelor's degree from Marycrest International University and his law degree from Drake University.

Joseph Clamon oversees a range of legal services for each component of UIHC. Clamon previously worked as in-house counsel at UnityPoint Health in West Des Moines, advising leaders on various health care issues. Before this, he was an attorney with McDermott, Will and Emery, specializing in health law and life sciences. Clamon also was a judicial clerk for Judge Michael Melloy of the U.S. Court of Appeals for the Eighth Circuit. He's an adjunct assistant professor in the College of Public Health at the University of Iowa. He previously held adjunct professorships at the Drake University Law School and Drake University College of Pharmacy and Health Sciences. Clamon received his law degree from the University of Iowa and his bachelor's degree from the University of Notre Dame.

Pete Deegan is a former U.S. attorney and criminal chief for the Northern District of Iowa and is now a partner at Taft. For most of his 22 years with the Department of Justice, Deegan was a federal prosecutor specializing in white-collar and business crime, including health care offenses. Deegan now practices in the compliance, investigations and white-collar defense practice group at Taft. He practices in Cedar Rapids and Taft's offices in Chicago and Washington, D.C. Deegan earned his bachelor's degree from the University of Notre Dame and his law degree from Wayne State University.

Clare Kelly is IHA's chief advocacy officer. She leads the advocacy team's policy development and advocacy strategy at the state and federal levels of government and oversees the association's communications team. Before joining IHA in August 2023, Kelly served as health policy adviser to Gov. Kim Reynolds, was CEO of the lowa Medical Society and spent 12 years in Washington, D.C., working in government affairs and child health policy for children's hospitals. She graduated from the University of Iowa.

Peter Lapointe is an associate at Finley Law Firm in Des Moines. Lapointe practices in a number of areas of civil litigation, including representing licensed health professionals and health care facilities. Prior to joining Finley, Lapointe graduated from the University of lowa with a bachelor's degree in political science and earned his law degree from the University of lowa College of Law.

Richard Korman, Esq., is the chief legal officer and general counsel for Avera Health in Sioux Falls, South Dakota. Korman directs Avera Health's legal, compliance, internal audits, liability and workers' compensation insurance products, contract and policy management, institutional review boards and risk management activities. Additionally, he oversees government relations strategies for the five-state region and directs Avera's positions on state and federal public policy initiatives. Korman manages outside legal counsel activities involving medical malpractice, regulatory investigations and civil litigation matters, oversees consultants who provide internal audit and compliance services and participates on executive management and strategic committees. He received his bachelor's degree in political science from the University of Minnesota and his Juris Doctorate from William Mitchell College of Law.
