## Governing Body and Medical Staff Conditions of Participation

### PROGRAM OVERVIEW

Over the years, regulators and accrediting organizations have been increasingly scrutinizing the hospital governing body's role in its compliance with the conditions of participation. This presentation will examine the regulatory requirements for hospital boards and describe situations in which the governing body has been cited at the condition level.

- Describe minimum requirements for medical staff bylaws, rules, regulations and governing body oversight.
